1.1 Nominee Director/Shareholder Services

In Singapore, it is required that the company must have at least 1 Director, 1 Shareholder and 1 Local Director (mandatory) in order to incorporate a company. This information will have public access and you can prevent it by using our Nominee services.

With our Nominee Director and Nominee Shareholder services, your identity will be absolutely safe and confidential from the public records.

- Fulfilment of legal requirements.
- Managing your asset at a high level.
- Protecting your identity from company's document and government's record
- Keeping your information confidential within your company structure and government.
- Fully control of your company activities through Power of Attorney (POA) and Declaration of Trust (DOT).

- Service fee is per annum/per appointment.
- The service fee does not cover the fee for couriering the original copy of the POA or DOT to your residential address.
- You can open a bank account for your company with the POA and/or DOT we provided.
- Certification by public notary or Apostille is required for nominee services in Hong Kong, United Kingdom and Singapore.
- An Apostille is a certification and legalisation of documents by the government, normally the General Registry/Court of the local country.

1.2. Company Renewal

As your Registered Agent/Company Secretary, it is our duty to remind & support you to renew and comply with any legal requirement asked by the government.

Renewal is a must to all company, in order to keep its good standing status with the government, maintain the business and also the company bank account.

Depend on each jurisdiction, the annual due date will be different and we will remind you on time about this to avoid any penalty fee.

2. Bank Account Opening Service

Singapore companies are welcome to open an account in many banks in the world, namely local banks (OCBC, DBS, UOB, etc.) or international banks (Maybank, UOB Malaysia, Standard Chartered, etc.). Furthermore, offshore banks in low or free tax are also keen on Singapore incorporations such as Euro Pacific Bank (Puerto Rico), CIM (Switzerland), Maubank (Mauritius), Bendura Bank (Liechtenstein), etc.

ACRA does not require small private companies to submit audited financial statements if they meet two of the three following criteria:

- Total annual revenue from the past fiscal year is less than S\$10 million.
- Total assets from the past fiscal year are less than S\$10 million.
- Total employees in the past fiscal year are fewer than 50.

Depending on the type of business of your Singapore company or even company name only, it is sometimes necessary to obtain a license and/or approval when you register your business with Accounting and Corporate Regulatory Authority (ACRA). ACRA's automated system will indicate if another approving authority is required to grant a business license or permit during the application for name approval.

Requirements for company incorporation in Singapore:

The company name must be approved before you can proceed with the incorporation of a Singapore company.



A company needs to have at least one shareholder who can be a local or foreign individual or company.



A qualified company secretary has to be appointed. The secretary must be a resident of Singapore.



At least one of the directors must be a natural person, above the age of eighteen years old, and a resident of Singapore.



Company must have a physical, local address in Singapore.

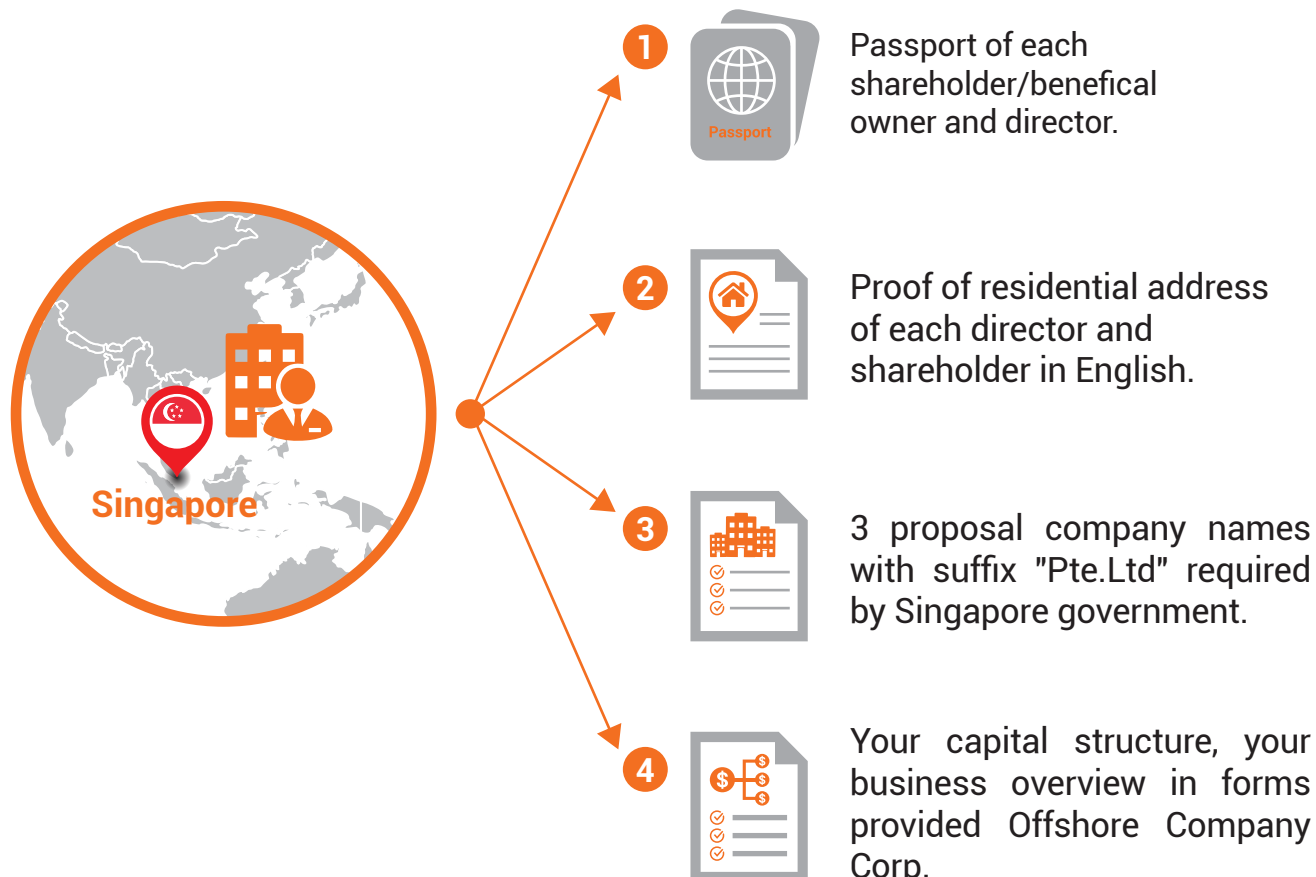


A shareholder who is a natural person can also be a director of the company.



The company must have a paid up capital of at least \$1.

Required document for Singapore company formation:
